Middletown Area School District will utilize multiple avenues to determine the most important educational needs. We will be utilizing programs that will assess the learning levels of each student and then we will use the data in a team approach, to come up with remediation avenues and pathways to recover the learning loss. The ways to determine important educational needs is to look at the amount of students who are not succeeding in cyber school. From this data we will look to improve our distance education learning options as well as strengthening our cyber programs. Other ways we are looking at determining educational needs is to evaluate the current mental health of our student's and staff. With this being said we will be using universal screeners to gauge the current mindset of the staff and then evaluate what supports we can put in place to consistently support our students and staff.

Middletown Area School District has already implemented services and assistance for students and staff starting July 1, 2020. Our timeline for deployment of services and assistance is being implemented throughout the school year and will continue until June 30, 2022. We have built a spending plan and implementation of services that will allow for all monies to be spent by June 30, 2022.

The LEA will utilize funds to pay for teacher's salaries to provide assistance to students enrolled in remote instruction. This will be a support mechanism that will allow for students who are struggling with materials through the remote leaning environment. Middletown Area School District will look to assess and address student learning gaps by the use of remediation programs such as I-ready to evaluate the learning loss gaps and deficiencies in students based on the disruption of educational services. Another way to address these gaps will be looking at failure rates within the schools and then determining what supports we can put in place to make sure students are overcoming the learning loss. In order to address this learning loss we will look to bolster our assessment practices, professional development for remediation teaching strategies and engaging in supporting students and staff when needed to address situations that arise from data pulls that are showing learning gaps.

Areas of emphasis should include:

The LEA is looking to use various assessment data to insure that we are documenting learning loss. This can be done through the use of technology based assessment, failure rates, and dropout rates. The goal of this documentation is to insure that we are assessing the learning loss and putting support plans in place to make sure students are closing those gaps. Part of the plan will also address the mental health and wellness of students who are in our vulnerable populations. The at-risk students are one of the major focuses of our plan. We are using ESS and other programs to help aid in the professional development of staff engaging students in these groups as well as supporting them academically. The goal of all of our plans is to continue to support students and close the gap of learning loss and also to support students and staff mental health.

We have also engaged in using professional development strategies to enhance our current face to face instruction to makeup for the learning loss that has occurred during the COVID-19 pandemic. We are also focusing on making sure our support systems for mental health supports for students and staff are extended. Research has shown this a vital part of learning enhancement and engaging students in a positive learning environment post pandemic.

The Middletown Area School District will utilize the use of I-Ready, Redbird, and other assessment tools to assess the continual closure of the learning gaps caused by COVID-19. We will look to insure that our remote learning options and cyber school are operating with continued success and are constantly engaging students in a positive learning environment that will allow them to succeed. Also, we are looking to engage students in the use of universal screeners. The implementation of Universal Screeners allows us to continually assess the mental health and wellness of our students. Studies have shown that a positive mental health and wellness will allow for students to succeed academically and overcome learning gaps.
